

FIGHT AGAINST BRIBERY AND CORRUPTION, PREVENTION OF LAUNDERING PROCEEDS OF CRIME AND FINANCING OF TERRORISM, TAKING MEASURES AGAINST PERSONS WITH CORPORATE INFLUENCE, COMPLYING WITH ALL NATIONAL AND INTERNATIONAL SANCTIONS/RESTRICTIONS

This document contains the commitments to be given by Fraport TAV Antalya Terminal İşletmeciliği A.Ş. ("Fraport TAV") in the areas of anti-bribery, anti-corruption, laundering of proceeds of crime, prevention of financing of terrorism, taking measures against persons with corporate influence, acting in compliance with all kinds of sanctions and restrictions to be determined nationally and internationally.

Fraport TAV is committed to comply with all relevant national and international laws, regulations and standards regarding anti-bribery, anti-corruption, prevention of laundering proceeds of crime and financing of terrorism, measures against corporate influential persons and sanctions/restrictions to be determined nationally and internationally. This commitment includes the obligation to comply with all national and international legislation in the countries where Fraport TAV operates/will operate, in particular those that criminalize corruption, influence peddling, abuse of trust, obtaining illegal benefits, misappropriation of public funds, nepotism or any other act that violates integrity.

Fraport TAV must not engage in behavior or events that may be characterized as active or passive corruption, facilitation payments or participation in influence peddling. Fraport TAV refrains from offering or paying improper remuneration to, or requesting such remuneration from, its business partners or persons with whom its business partners are affiliated. It undertakes to ensure that all its employees and Third Parties with whom it has business relations comply with this obligation. Fraport TAV undertakes that negotiations will be conducted without offering any benefits such as invitations and gifts to business partners or potential business partners, and in compliance with the requirements of loyalty, good faith and independence. However, in order to maintain good relations, it accepts that gifts of symbolic value, reasonable meals and entertainment may be given and received in a measured and transparent manner within the limits specified in the "FTA Code of Ethics-Employee Guide".

Fraport TAV undertakes not to provide or request sensitive or confidential information in order to obtain preferential treatment for itself or any other party.

ESTABLISHING THE INTERNAL COMPLIANCE SYSTEM

Fraport TAV declares that it has in place a system of appropriate rules, systems, procedures and controls to prevent corruption, influence peddling, abuse of trust, obtaining illegal benefits, misappropriation of public funds or any other act that violates integrity.

OBLIGATION TO INFORM

Fraport TAV agrees to demonstrate full transparency by immediately informing the addressee in writing in the event of any of the following situations: Any conviction of Fraport TAV, any of its employees, agents or partners for corruption, influence peddling, breach of trust, obtaining illegal benefits, misappropriation of public funds, nepotism or any other act of dishonesty. Fraport TAV undertakes to provide all kinds of information to its employees about the methods of using its own warning system. This information will also include the protection of whistleblowers. Fraport TAV undertakes to ensure that its suppliers also comply with the principles set forth in this article.
