

FIGHTING AGAINST BRIBERY AND CORRUPTION, PREVENTING LAUNDERING OF PROCEEDS OF CRIME AND FINANCING OF TERRORISM, TAKE MEASURES AGAINST INDIVIDUALS WITH INSTITUTIONAL INVOLUNTARY POWER, ACTING IN ACCORDANCE WITH ALL NATIONAL AND INTERNATIONAL SANCTIONS/RESTRICTIONS

This document contains the commitment of Third Parties who will have a business relationship with Fraport TAV Antalya Terminal İşletmeciliği A.Ş. ("Fraport TAV") to combat bribery, corruption, money laundering, and financing of terrorism, to take measures against individuals with corporate influence, and to comply with all sanctions and restrictions determined nationally and internationally. with all kinds of sanctions and restrictions to be determined nationally and internationally.

The Third Party undertakes to comply with all relevant national and international laws, regulations, and standards regarding bribery, anti-corruption, anti-money laundering, counter-terrorism financing, measures targeting corporate influential individuals, and sanctions/restrictions to be determined nationally and internationally throughout the term of the Agreement. This undertaking includes the Third Party's obligation to comply with all national and international legislation in the countries where it operates, particularly those criminalizing corruption, influence peddling, abuse of trust, obtaining unlawful benefits, embezzlement of public funds, nepotism, or any other acts that violate integrity.

The Third Party must avoid conduct or events that could be considered active or passive corruption, facilitation payments, or participation in influence peddling during the negotiation and execution of contracts. The Third Party refrains from offering, paying, or soliciting improper compensation to business partners or their affiliates. It undertakes to ensure that all of its employees comply with this obligation. The Third Party undertakes that contract negotiations will be conducted in accordance with the requirements of loyalty, good faith, and independence, without offering any benefits, such as invitations or gifts, to business partners or potential business partners. Furthermore, it agrees that gifts of symbolic value, as well as meals and entertainment of reasonable amounts, can be exchanged in a measured and transparent manner, within the limits specified in Fraport TAV's "FTA Code of Ethical Conduct," published in Turkish and English and available at the address below.

The Third Party undertakes not to provide or request sensitive or confidential information for the purpose of obtaining preferential treatment for itself or any other party.

ESTABLISHING AN INTERNAL COMPLIANCE SYSTEM

The Third Party acknowledges that it has implemented, or will implement within two months of the contract award, a system of appropriate rules, systems, procedures, and controls within its company(ies) to prevent corruption, influence peddling, abuse of trust, illicit gain, misappropriation of public funds, or any other acts that violate integrity. This system must be appropriate to the size and organization of the Third Party. This system must also accommodate any changes to the regulations referred to in this document. The Third Party undertakes to maintain this system without any suspension throughout the term of the contract.

OBLIGATION TO INFORM

Sözleşmenin ifası boyunca, Üçüncü Taraf, aşağıdaki durumlardan birinin meydana geldiğini yazılı şekilde Fraport TAV'ı derhal bilgilendirerek tam bir şeffaflık göstermeyi kabul eder: Yolsuzluk, nüfuz ticareti, güveni kötüye kullanma, yasa dışı menfaat elde etme, kamu fonlarını zimmete geçirme, adam kayırmacılık ya da dürüstlüğü ihlal eden diğer tüm eylemler nedeniyle Üçüncü Taraf'ın, herhangi bir çalışanın, temsilcisinin ya da ortağının hüküm giymesi. Üçüncü Taraf, yukarıda bahsi geçen şirket içi kurulan sistem çerçevesinde sistem kurulmadan önce tespit edilen yolsuzlukla mücadele ihlallerini de bildirmeyi taahhüt eder. Üçüncü Taraf, Fraport TAV'ın ilk talebinde yukarıda atıfta bulunulan sistemin etkili bir şekilde uygulandığına ilişkin kanıt sunmayı taahhüt eder. Üçüncü Taraf, kendi uyarı sistemini kullanma yöntemleri konusunda çalışanlarına her türlü bilgilendirmeyi yapmayı taahhüt eder. Bu bilgilendirme kapsamında, ihbarda bulunan şahısların korunması da yer alacaktır. Üçüncü Taraf, tedarikçilerinin de bu maddede öngörülen ilkelere uymasını sağlamayı taahhüt eder.

TERMINATION OPTION

In case of occurrence of the above mentioned situation/s and/or if the Third Party does not comply with the obligations stated in this document, Fraport TAV may terminate the contract for just cause.
